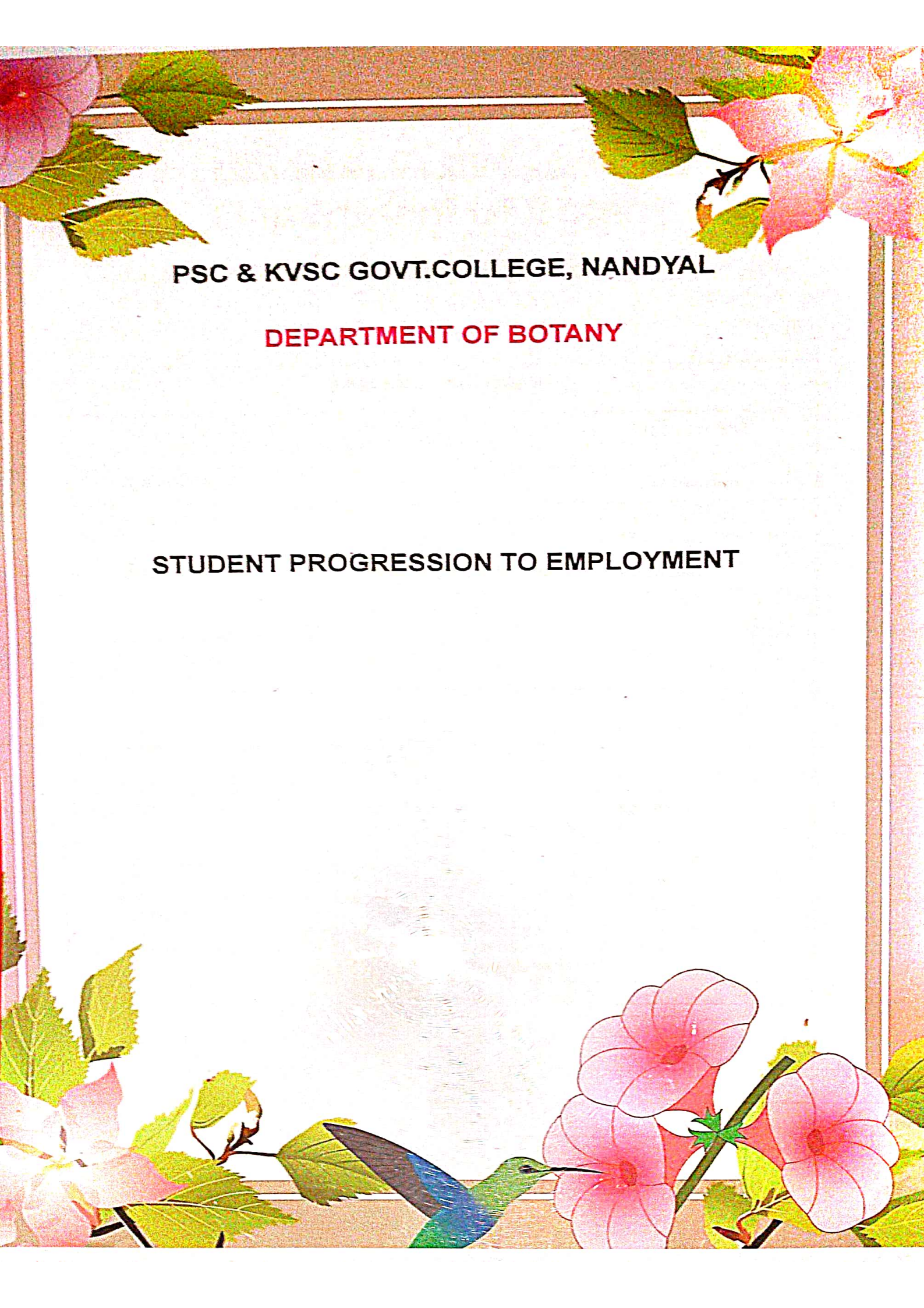

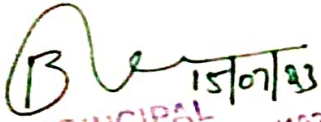

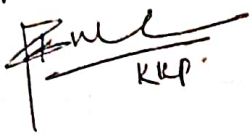
1. You will be under training for a period of one year from the date of your joining. You will be paid remuneration an amount of 13,500/- per month.
